Overview of 2015 Summer Programs

Program	Description	Projected Enrollment*
Summer Plus	Full day academic and enrichment for students in grades K-7	3,200 students
ESY	Special education summer program, as guaranteed via IEP. Includes self-contained classes, integrated classes, and Pre-K services.	500-600 students
English Plus	Summer program for bilingual/ESL students in grades K-7. Integrated into Summer Plus.	700 students
High School Credit Recovery	Credit-earning opportunities for high school students.	2,000 students

Involve a broader array of community-based organizations (CBOs) 	<ul style="list-style-type: none"> • The Office of Expanded Learning Time released a RFP, which was open to all CBOs, and provided an info session for CBOs. • 13 CBOs sent proposals, an increase from the 4 CBOs in 2014.
Build stronger connections between CBOs and NPS staff  <i>In 2014, program evaluation surveys of teachers and staff identified coordination with partners as an area in need of improvement.</i>	<ul style="list-style-type: none"> • NPS staff will design enrichment programming, which will be led by the principals and ELT Site Coordinators. <p><i>Therefore, CBOs can focus on the services they best provide, rather than program administration, which was found to be a weakness last year.</i></p> <ul style="list-style-type: none"> • NPS teachers will co-develop enrichment content (for example, arts integration lessons) to incorporate teacher expertise in the program structure.

<p>Better inform families of the enrollment process to encourage their participation.</p> <p><i>Application open April 10-May 10, 2015</i></p>	<ul style="list-style-type: none"> • Schools received information for distribution, including: parent backpack letters, parent guides, and info flyers. • Multiple notices about the application process went to families via Blackboard Connect messages—as well as the NPS web site, text notifications, and Twitter updates. • The NPS summer website was re-launched with clearer info for families (www.nps.k12.nj.us/summerprograms). <ul style="list-style-type: none"> ○ The list of summer school sites is available on the NPS web site. • The Contact Center was trained to respond to family inquiries about Summer Plus.

<p>Provide equal access for all families, regardless of economic means</p> 	<ul style="list-style-type: none"> All programs, including the 3-6PM Extended Day Option, will be free again. Translated application and info materials were available.
<p>Appeal to families who want flexibility in their summer calendar</p>  <p><i>Last year's pilot of expanding to 6 weeks showed the largest daily attendance drop-off between weeks 5 and 6.</i></p>	<ul style="list-style-type: none"> Program will return to being 5-weeks-long.
<p>Promote consistent attendance</p> <p><i>In 2014, NPS collected the most complete benchmark data to date. This data identified the extent of no-shows and the attendance issue.</i></p> 	<ul style="list-style-type: none"> In 2015, Community Engagement Specialists will call all absent students each morning, in order to capture the reasons behind no-shows. NPS is focusing on improving program quality in order to increase participation in Summer Plus over time.
