This scholarship is being offered to all high school seniors who meet the following criteria:

- United States Citizen
- A New Jersey resident for 5 years
- Presently pursuing a degree at a New Jersey college or university (two- or four-year) as an undergraduate or graduate student (part- or full-time),
- Be maintaining at least a 3.0 GPA on a 4.0 GPA grading scale.
- Be interested in the water utility industry or in any related field, such as, natural resource management, environmental sciences, biology, chemistry, engineering, communication, computer science, business administration, human resources, consumer affairs, law, accounting, finance, etc

The application must be postmarked no later than April 1, 2020. In addition, it is the responsibility of the student to see that we receive three letters of recommendation plus a copy of their transcript by April 10, 2020. All items should be directed to Gail P.
