

## **Better Speech and Hearing Month**



## Special Education Week NJ celebrated the 2nd week of May

The Office of Special Education would like to take this time to thank all Special Education Teachers for their dedication and commitment for ensuring a safe and caring learning environment for all of our exceptional learners. A token of appreciation is being sent to all special education teachers at Newark Public Schools. Special Education Teachers can stop by their CST office to pick up their gift.

Due to the Mills v. Board of Education lawsuit in 1971, the courts ruled it unlawful to deny children with mental and learning disabilities access to public education. Since then other legislation became law to protect the educational rights of students with disabilities.

- Education for All Handicapped Children Act 1975, required states that accepted federal money to provide equal access to children with disabilities
- 1986 legislators included protections for parents and educators which led to the creation of an education plan for students with disabilities
- Individuals with Disabilities Education Act (IDEA) 1990, makes available a free and appropriate public education (FAPE) and ensures that special education and/or related services are provided to students with disabilites
- In NJ, Section: 18A:36-5: "Special Education Week" was created to recognize the contributions of families, community agencies, school boards and schools in their support of students with disabilities

## Office of Special Education & Gallaudet University - Clerc Center Collaboration

The Office of Special Education (OSE) is excited to announce the upcoming visit from The Laurent Clerc National Deaf Education Center (Clerc Center) at Gallaudet University. The Clerc Center works with schools and programs to identify training and technical assistance needs to enhance, improve, or modify existing programs to maximize instructional practices, student support services, and leadership strategies with the goal of improving the achievement levels of deaf and hard of hearing students nationwide. During Phase 1, May 31 - June 2, 2022, Marianne Belsky, Chief Academic Officer from the Laurent Clerc Center will visit Bruce Street School for the Deaf and the Auditory Impairments Program at Technology High School to conduct classroom observations of the programs, review current curriculum materials and will meet with key stakeholders at the two schools. At the conclusion of the site visit, the Clerc Center will provide OSE with a summary of the site visit and a proposal for the upcoming 2022-2023 academic year's future visits and trainings.
