Phonics Program Updates for Special Education Teachers K-8

The Office of Special Education is collaborating with the Office of English Language Arts to support special education teachers having access to implementing a phonics program from grades K to 8th grade (self-contained). During August and October, SIPPS materials for special education self-contained classes grades 2-3 have already been shipped to schools. Mr. Cullens, Special Assistant to OSE is following up with principals and their ELA coaches.

The Office of Special Education and The Office of English Language Arts are collaborating to purchase Fundation materials for grades K-1 and SIPPS materials for grades 4-8. Autism Supports by Star Autism

On behalf of the Office of Special Education, we want to welcome you back to the second half of our school year, Happy New Year! In order for us to best support our students on the Autism Spectrum with evidence based practices, we will continue our partnership with **Star Autism**. The Star trainers will be continuing to work in our district schools with Autism Programs. OSE has 2 model classrooms in each school with an autism program. Cohort 2 Teachers have resumed for the 2023-2024 SY and Cohort 3, composed of Autism teachers new to autism classrooms or new to the district, will receive training, materials, monthly coaching and feedback from Star Consultants.

In-Class Consultations (In-Person) Scheduled Throughout the Year:

Direct consultation with teachers, paraprofessionals and related service staff on the implementation of evidence-based practices using the STAR Program and/or Links Curriculum. Consultation can include general classroom implementation of the curriculum as well as individual student planning +and progress monitoring. Modeling of fidelity of implementation of lessons and use of positive behavior supports will be provided. Classroom consultation activities focus on active learning including observation, practice and collaboration.

The (APQI-R) is a guidance document developed by the New Jersey Department of Education (NJDOE) that is meant to serve as a resource for Local Educational Agencies (LEAs) in developing, implementing, and evaluating quality programming for all students on the autism spectrum disorder (ASD). Handle with Care Training (Autism and ERI Program)

At this time, priority is being given to paraprofessionals and educational staff supporting the Autism and ERI programs, and security officers. To learn more about the program you can review the HWC Official Web Page by clicking here <u>HANDLE WITH CARE® Behavior Management System</u>. The HWC training provided in the district is a <u>2 day training being conducted at Harold Wilson</u>.

- **Day #1- VERBAL TRAINING** focuses on preventing behavior issues and de-escalation techniques that school staff can use to address students who are having difficulty. These verbal and non-verbal de-escalation skills enable staff to reduce tension, and create and maintain a calm and safe environment for all. (Max 60 participants).
- Day #2- PHYSICAL TRAINING- participants will focus on a variety of avoidant and protective physical techniques, as well as the passive Primary Restraint Technique (PRT). The PRT is therapeutic hold only to be used when a student is deemed a danger to themselves or others. The PRT is an easy to learn, orthopedically safe, and effective standing method that offers unprecedented mechanical advantage without pain or injury to students or staff. (Max 20 participants). <u>Staff should dress comfortably to actively participate in the physical activities of Day #2, including wearing rubber soled shoes or sneakers</u>.
