	Ward	The ward the school is located.			
	School Type	A designation of whether the school is an elementary, elementary/middle, selective magnet, comprehensive (for high schools only), special education, transfer high school, selective magnet high school, or comprehensive high school			
	Grades Served	The span of grades served in this school during the 2018-19 school year			
	# of Students Enrolled	Number of students enrolled Oct. 15th, 2019. Data from October 2019 state submission.			
	Percent Qualifying for Free Lunch	The percent of students who qualified for free meals as of Oct. 15th, 2019. This is a measure of low income. Families qualify for free lunch if their income is less than 130% of the poverty level. Data are from the October 2019 state submission.			
	Percent with IEP	Percent of students classified with a disability as of Oct. 15th, 2019. Data are from October 2019 state submission.			
	Percent in self-contained programs	The percent of students in self-contained classrooms to students as of Oct. 15th, 2019. Data are from October 2019 state submission.			
	Limited English Proficient	Percent of students classified limited English proficient as of Oct. 15th, 2019. Data are from October 2019 state submission.

TEACHER & CLASS INFORMATION	Percent of Teachers with Five or More Year of Experience/Service	The percent of teachers with five of more yeras of experience as of the end of the 2019-20 school year. This indicator includes experience gained in the district, but excludes experience gained outside of NPS. Experience is defined as the total years of service in a specific job title (which can be non-consecutive). Positions include all instructional staff at school sites. Instructional staff includes all subject teachers and academic interventionists. This indicator excludes administrators.
	Teacher retention from 2018-19 to 2019-20, by evaluation rating	teachers at the same school this academic year (2019-20) who received effective or highly effective evaluation ratings. These indicators describe within-school retention and not retention in the district. The source dataset was limited to teachers who received an evaluation rating using the Framework for Effective Teaching. Teachers without an evaluation rating were excluded.
	Percent Instructional Staff Missing 4 days or fewer	The percent of instructional staff absent for four days or fewer. The analysis includes employees who were NTU-instructional, minus per-diems. For school-level statistics, a compromise was made to assign teachers to the school/location they were working during their last absence date. For the 19-20 school year the attendance data is reported through 3/13/2020 due to Covid-related data quality challenges.
	Student-Teacher Ratio	The ratio of student enrollment to certified teachers. Students were defined as those actively enrolled during the 2019-20 school year and represented in the June 30th, 2020 count. Teachers were defined as those employees, as of June, 2020, with teacher certifications and job title descriptions such as Academic Interventionist and Teachers. Employees with job descriptions such as Teacher Coach, Teacher Aide, Home Interventionist, and Tchr of Home Instruction were excluded. Job title descriptions are broad categories and schools may not systematically apply a job title to refer to specific roles, so caution should be used when interpreting this indicator.
SCHOOL PROGRAMS & RESOURCES	Avg. section size (excludes self-contained classrooms)	For elementary/middle grades the average section size is calculated based on the number of students in homeroom sections. Homeroom section size is a proxy for section size throughout the school day in schools where cohorts of students move together throughout the day. Self-contained sections are excluded. Grade-level was attributed by the grade level in the course title (e.g., Homeroom 1, Homeroom 2, etc.) For high school grades the average section size is calculated based on the number of students in typical sections, excluding self-contained, lunch, and online sections. Sections taught by the same teacher at the same time were summed together. Data pulled from end of the 2019-20 school year.
	Bilingual education program(s)	List of language programs for English Language Learners that are planned to operate at each school for the 2019-20 school year.
	AP Participation Rate	AP Participation rate was calculated by dividing the number of students enrolled in at least one AP course by the total number of students enrolled as of October, 15th, 2019.

	Special Education Self- contained programs	This measure lists the self-contained special education programs offered at each school during the 2019-20 school year. A self-contained program is a separate instruction setting that serves students whose Individualized Education Plan requires one of the following: Auditory Impaired, Auditory-Multiple Disabilities, Autism, Behavioral Disabilities, Cognitively Impaired-Mild, Cognitively Impaired-Moderate, Learning Disabilities Mild/Moderate/Severe, Multiple Disabilities, Multiple Disabilities Medically Involved, Pre-School Disabled, Pre-School Disabled-Auditory, Pre-School Disabled-Autism, Pre-School Disabled-Medically Involved Special education program descriptions can be found at http://www.nps.k12.nj.us/departments/curriculum-services/office-special-

NDANCE	Students chronically absent	Percent of students who are "chronically absent" for any reason, e.g., excused, unexcused, etc. during the 2019-2020 School year. "Chronically absent" is defined as missing 10% or more of the days the student is enrolled. Some students switched schools in the middle of the school year. Students are attributed to the school they were enrolled in as of October 15, unless they were not actively enrolled in a school on that date, in which case they are attributed to their June 30th school. Attendance data is only available up through 3/13/2020.
ATTE	Average Daily Attendance	The average daily attendance was calculated by adding all of the total present days of attendance for all students divided by the total days enrolled for all students. Attendance data is only available up through 3/13/2020.
MOBILITY & ATTENDANCE	Transfers Out	This measures the percentage of a school's students that transferred out of the school after 10/15/19. It is calculated as the percent of students enrolled in a given school on 10/15/19 who were no longer enrolled in the school as of 6/30/20.
_	Transfers In	This measures the percentage of a school's students that transferred in to that school between 10/15/19 and 6/30/20. It is calculated as the percent of students enrolled in that school on 6/30/20 who were not enrolled in that school on 10/15/19.
STATE ASSESSMENTS	Percent Proficient	Percent of students scoring in levels 4 or 5 (met or exceeded expectations) on the ELA and Math portions of the NJSLA (or PARCC exam for the 16-17, and 17-18 school years). Due to Covid, there was no state administration during the 19-20 school year. Data presented represents results from the end of the 2018-19 school year.
STATE AS	PARCC: Avg Scale Score	Average scale score of students who took the the ELA and Math portions of the NJSL/ (or PARCC exam for the 16-17, and 17-18 school years). The possible range was 650-850. Due to Covid, there was no state administration during the 19-20 school year. Date presented represents results from the end of the 2018-19 school year.

GRADUATION & POSTSECONDARY OUTCOMES	4-year Graduation Rate	The percentage of students at the school who entered 9th grade four years earlier (in Fall 2016) and graduated in 2020, as is the case of the most recent year. This cohort also includes transfers into the school and excludes students who were verified as transferring out. Graduation rates presented do not factor in graduation appeals. 	Total Post-secondary Student Enrollment	This represents the percentage of high school graduates from 2019 who enrolled in a post-secondary institution in the fall of 2019.
