

QUALIFICATIONS - Candidates filing a nominating petition for board membership must meet the following qualifications pursuant to N.J.S.A. 18A:12-1:

- Be a United States citizen
- Be a resident of the district for at least one year at the time of election or appointment
- Be able to read and write
- Be a registered voter in the district where the person is submitting the nominating petition
- Not be “disqualified” as a voter pursuant to N.J.S.A. 19:4-1
- Has not been convicted of any of the crimes or offenses enumerated in N.J.S.A. 18A:12-1 or conspiracy to commit or attempt to commit any of said crimes.
- Board of education members may not, pursuant to N.J.S.A. 18A:12-2 and 12-3: i. Be the mayor or a member of the governing body of the municipality or, in the case of special services or vocational schools, the county, *or*
- **Have a direct, or indirect, contract with or claim against the board.**

IMPORTANT INFORMATION

- Within 30 days of election or appointment to the board, a member must undergo a **criminal history background investigation** through the New Jersey Department of Education.
- The School Ethics Act and nepotism legislation impact the ability of board members who have relatives working in the school district to act in areas such as personnel and collective negotiations. Please consult your board secretary for details.

(Note: Board Secretaries are encouraged to fill out this section prior to distribution to school board candidates.)

Completed nominating petitions shall be filed with the secretary of the board on or before 4:00 p.m. of the fiftieth day preceding the date of the election, which is **March 2, 2026**. The board office is located at 765 Broad Street, Newark, N.J. 07102 and the days, dates and business hours during which the office is open to receive petitions are: Monday – Friday, 9:00am – 4:00pm.
